

# UNCLE DAVE MACON DAY'S 35th ANNUAL OLD TIME MUSIC & DANCE 2012 ARTS & CRAFTS APPLICATION

Thank you for your interest in the Uncle Dave Macon Day's Music and Dance Festival. The event features national grand-championship competitions in old time music, buck dance and clogging, Trail Blazer and Heritage awards, a variety of arts, crafts, food, storytelling and impromptu jam sessions. The festival is operated by the non-profit Dave Macon Commission, and held at the Cannonsburgh Village Park that is owned by the City of Murfreesboro. A small creek meanders through the 10 acre site which divides the competition area and village setup. The Dave Macon Day's partnership with the City of Murfreesboro, WSM Radio and extensive local and regional media coverage attracts an average attendance of 30,000. A gate fee of \$5 is charged.

*"The Village of Cannonsburgh"* reserved for traditional craft, or living trades. Demonstrations encouraged in blacksmithing, tinsmith, soap making, weaving, clothes washing, food preservation, basketry, fiber, furniture, glass, jewelry, leather, metal, mixed media, paper, wood, music instruments.

*If I am accepted as an Uncle Dave Macon Days Vendor:*

	I understand that Vendors must furnish their own tables, tent, chairs, etc.
	I understand that the producers of the festival will determine and issue my booth placement at check-in. Requests for a specific booth space cannot be guaranteed
	I understand that <u>One parking pass</u> is provided for each approved vendor. Additional vehicles \$5. RV's, etc. require a weekend parking fee-collected at the gate. Additional vehicles may park free at the offsite parking garage
	I understand that my space rental fee is not refundable after June 1, 2012 (Unaccepted fees returned)
	I understand that the festival does not carry insurance to cover my personal property and that I store and display my products at my own risk
	I understand that the festival makes no sales guarantees
	I understand that merchants are not allowed to encroach nor solicit outside their assigned booth space, or otherwise cause harm or distress to neighboring booths, their sales or service
	I understand that receipt of my application does not guarantee my acceptance
	I understand that No commission is charged on sales, that UDM is not responsible for tax collections, that it is my responsibility to contact the Tennessee Department of Revenue
	I understand that Plastic/inflatable toys, food glow lights, drinks may not be sold from my booth

**Guidelines:** All works made, assembled, or embellished by the exhibitor, no mass manufactured artwork, crafts, games, or work made from commercial molds, kits, or copyrighted designs not owned by the craft artist will be accepted. All prints and photographs must be fully executed by the exhibitor. If you do not meet this requirement the Committee reserves the right to request any item not meeting its guidelines, not listed on your application, or deemed inappropriate, to be removed from your booth, or expulsion from the event. The committee reserves the right to limit, duplicate, or refuse application from vendors who do not meet show criteria, or are classified in categories previously filled by the time of application receipt.

**Risk and Liability:** The undersigned agrees to protect, defend, indemnify and hold the Dave Macon Festival Commission, City of Murfreesboro, its officers, employees, and agents free and harmless from any and all losses, penalties, damages, settlements, costs, charges, professional fees, or other expenses or liabilities of every kind and character arising out of or relating to any and all claims liens, demands, obligations, actions, proceedings, or causes of action of every kind and character in connection with or arising directly or indirectly out of this agreement and/or respond to, provide defense for and defend any such claims, etc., at his/her sole expense and agrees to bear all other costs and expenses related thereto, even if it (claims, etc.) is groundless, false, or fraudulent.
