The event features national grand-championship competitions in old time music, buck dance and clogging, Trail Blazer and Heritage awards, a variety of arts, crafts, food, storytelling and impromptu jam sessions. The festival is operated by the non-profit Dave Macon Commission, and held at the Cannonsburgh Village Park that is owned by the City of Murfreesboro. The Dave Macon Day's partnership with the City of Murfreesboro, WSM Radio and extensive local and regional media coverage attracts an average attendance of 30,000. A gate fee of \$5 is charged.

If I am accepted as an Uncle Dave Macon Days Vendor:

	I understand that I will furnish my own equipment, tables, tent, chairs, etc. and they will be in original, or professionally repaired working order. Extension cords must be rated at no less than 20 amps for the available power outlet
	I understand that <u>One parking pass</u> is provided for each approved vendor. Additional vehicles \$5. RV's, etc. require a weekend parking fee-collected at the gate. Additional vehicles may park free at the offsite parking garage
	I understand that no grease/oil is to be left behind, poured in any drain, or receptacle not designed for oil recycling
	I understand that my fee is not refundable after May 1, 2012 (Unaccepted photos/fees returned)
	I understand that the festival does not carry insurance to cover my personal property and that I store and display my products at my own risk
	I understand that I must comply to remove any item requested by show management and prices must be displayed at all times.
	I understand that flashing lights, sirens, loud speakers music, roaming or peddling of foods are not allowed
	I understand that receipt of my application does not guarantee my acceptance
	I understand that additional supplies must be piped/draped or neatly kept/covered
	I understand that I may sell beverages (soft drinks, coffee, tea, root beer) and that no alcoholic beverages are permitted.
	I understand that the local Health Department will inspect my booth and collect a permit fee
	I understand that No commission is charged on sales, that UDM is not responsible for tax collections, that it is my responsibility to contact the Tennessee Department of Revenue
